School Description and Mission Statement

Roosevelt International Middle School is an authorized International Baccalaureate Middle Years Program (IB MYP) school located at the northeast edge of Balboa Park. The school was built in 1922 and reconstructed in 1974 on the original site. There are some 820 students enrolled for the 2009–10 school year. The student population is very diverse and comes from the many neighborhoods surrounding the school: downtown, Golden Hill, North Park, Hillcrest, and Mission Hills.

At Roosevelt, we understand the urgency to improve our students' abilities in literacy and mathematics. We understand that we are all teachers of reading in our curriculum areas. The mission of Roosevelt is to develop a community of high-achieving, lifelong learners who collaborate with parents and staff members to create a better world through inquiry, intercultural understanding, and respect. Opportunities for Parent Involvement

We are committed to communicating with and engaging parents as partners in their children's education. The district has adopted *Parent Communications and Involvement Standards*, which clearly describe expectations for parent communications and involvement at the district, school, classroom, and home levels. School Climate

School Safety Plan (2009–10)

Last Review/Update: January 2009

Last Discussed with Staff: February 2008

Each school has a Crisis Response Box that includes its state-mandated comprehensive school safety plan. This plan meets the state requirements described in California Education Code Sections 35294–35297. The safety plan includes disaster procedures, procedures for safe entry and exit of students, procedures for serious disciplinary problems, a sexual harassment policy, child abuse reporting procedures, school dress codes, and school discipline policies.

Adult supervision is provided in the classrooms and outside areas before and after school, during recess and lunch, and during passing time between classes. Under the direction of the principal or site administrator, school staff members implement specific school-building security procedures. In addition, district offices support schools by reviewing and disseminating safety requirements and information, coordinating safety-related services, and providing safety training and assistance.

Roosevelt's campus gates are open from 5:30 a.m. to 7:30 a.m. Once classes are in session all gates are closed. The campus gates re-open five minutes before school dismissal. All visitors to the Roosevelt campus must check in with the main office and receive a visitor's pass. Persons under the age of 18 are not permitted on campus without a parent or guardian who has been cleared for campus entry by the office staff. In addition to the aforementioned security measures, we have a full-time campus police officer and a full-time campus security assistant who actively monitor and patrol the entire campus before school, throughout the school day, and after school. Also, teachers and school staff are scheduled at various stations before school and at dismissal time in order to ensure the safety of all students at these two critical times of the day.

Suspensions and Expulsions

The following table shows the numbers and rates of suspensions and expulsions. Rates per 100 students are the total number of incidents divided by the school's enrollment for the given year, multiplied by 100. The district comparison rates are the expected rates for the school's enrollment and grade-level composition, based on actual districtwide rates. Because suspension and expulsion rates vary greatly by grade level, and since any given two schools are not likely to have identical enrollment numbers per grade, schools will have different district comparison rates.

School Facilities

School Facility Conditions and Improvements (2010–11)

Roosevelt's grounds and facilities are well kept. The entire exterior of our school was painted in January 2007. A few years ago, with the assistance of Proposition MM, several of our buildings and classrooms were remodeled, rooms were painted, and new flooring and whiteboards were installed. In addition, items such as ceiling tiles, doors, window assemblies, asphalt and concrete paving, the irrigation system, fencing, carpeting, the heat/ventilation system, and the air-conditioning system were either repaired or replaced. An elevator has been added to the northeast corner of our 300 building, our library and counseling center have been remodeled, and two new computer labs and three new science classrooms were added.

We have a building services supervisor and two full-time custodians to maintain cleanliness of the campus. Classrooms are cleaned every three days. Our landscaping is maintained by a district team every two to three weeks. Our staff and students strive to keep our campus clean and graffiti-free, and our custodial staff works to ensure that our campus promotes a positive learning environment.

Instructional Planning and Scheduling

Professional Development

Through the district’s educational strategies, the Instructional Support Services Division collaborates with other departments to provide teachers and administrators with ongoing professional development to improve teaching and learning in the areas of literacy, mathematics, science, history–social studies, visual and performing arts, physical education, health, educational technology, and gifted and talented education. Sessions focus on differentiating instruction to meet the needs of all learners and often target the needs of our English language learners, Special Education students, and other struggling learners. Each year, principals identify a focus for schoolwide professional development and determine areas of individual need. Throughout the year, principals conduct large- and small-group staff conferences and coach teachers at the school site to improve instructional practice.

- Targeted Instructional Improvement Program—staff salaries, staff benefits, services, materials, and support for low-achieving students
- School-Based Coordinated Program—staff salaries, staff benefits, services, materials, and support for our lowest performing schools
- Gifted and Talented Education Program—specialized learning assistance for identified students of high ability, achievement, or potential
- Special projects—monies from agencies (federal or state) earmarked for specific programs/projects or services
- Transportation
- Maintenance and operations
- District administration

Each school in the district receives an instructional budget based on enrollment, programs, and formulas set by Board of Education policy, state law, agreements with employee bargaining units, and guidelines of outside funding sources.

Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CST), the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA).

The CSTs show how well students are doing in relation to the state's content standards. The CSTs include English–language arts (ELA) and mathematics in grades 2–11; science in grades 5, 8, and 9–11; and history-social studies in grades 8, 10, and 11.

The CMA is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards, with or without accommodations. The CMA includes ELA for grades 3–8 and science for grade 5.

The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CAPA includes ELA and mathematics in grades 2–11 and science in grades 5, 8, and 10.

STAR Program Results

STAR scores are ranked according to five "performance levels": Advanced (exceeds state standards), Proficient (meets state standards), Basic (approaching state standards), Below Basic (below state standards), and Far Below Basic (well below state standards). Students scoring at the Proficient and Advanced levels have met state standards in that content area.

National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America’s students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (basic, proficient, and advanced). The participation of students with disabilities and English language learners is reported based on three levels (identified, excluded, and assessed). Detailed information regarding the NAEP results for each grade, performance level, and participation rate can be found on the National Assessment of Educational Progress website at nces.ed.gov/nationsreportcard/.

Only a sample group of California’s schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects statewide test results and is not reflective of either the district or this school. Comparisons of student performance on the NAEP and student performance on the STAR Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades 4, 8 and 12. (The NAEP assesses grades 9, 13, and 17 for long-term trends.) In addition, the NAEP only provides statewide test results for grades 4 and 8. The California Standards Tests (CST) are based on a different set of standards from those of the NAEP. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English–language arts as a whole, encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
